

## **Toms River Chess Club Visitor Policy**

**Effective Date:** [10-1-2024]

### **1. Eligibility**

Visitors are welcome to attend TRCC events and activities as long as they are not suspended members or members not in good standing.

### **2. Registration**

Visitors must sign our visitor sheet upon arrival, providing their name and email (if applicable). All visitors under the age of 18 must also include an emergency contact.

### **3. Visitor Fees**

A nominal fee may be charged for visitors attending specific events or activities. Visitors will be informed of any applicable fees.

### **4. Behavior Expectations**

Visitors are expected to adhere to the Safe-Play Clause guidelines set forth by the TRCC. This includes treating others with respect, refraining from disruptive behavior, and following all TRCC rules and regulations.

### **5. Liability**

TRCC, its officers, directors, employees (if applicable), and volunteers shall not be held liable for any injury, loss, or damage arising from a visitor's participation in TRCC events and activities, except in cases of gross negligence.

### **6. Privacy Clause**

The Toms River Chess Club (TRCC) values the privacy of its visitors. Personal information collected during the registration process, such as names and contact information, will be used primarily for membership management, communication, event coordination, and maintaining club databases. TRCC will not share or sell personal information to third parties without consent, except as required by law. Visitors have the right to request access to their personal information when applicable and to make updates as needed. TRCC takes reasonable steps to protect your information but cannot guarantee complete security.

### **7. Arbitration Clause**

Any dispute, controversy, or claim arising out of or relating to this Visitor Policy, or the breach, termination, or validity thereof, shall be resolved exclusively through binding arbitration in accordance with the rules of the American Arbitration Association, unless TRCC, at its sole discretion, chooses to pursue the matter in court. The arbitration or court proceedings shall take place in Ocean County, New Jersey, and judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. Visitors waive any right to bring or participate in any class action or other representative proceeding against TRCC.

**8. Health and Safety**

Visitors who are feeling unwell are asked to stay home. Those exhibiting symptoms of illness may be asked to leave the event at the discretion of TRCC officers.

**9. Photography and Media Consent**

By attending TRCC events, visitors consent to being photographed or filmed for club promotional purposes.

**10. Conflict Resolution**

Visitors are encouraged to address any concerns or conflicts directly with TRCC officers for support.

**11. Child Behavioral Clause**

Children under the age of 12 must be accompanied by a parent or guardian at all times during TRCC events and activities. Parents or guardians are responsible for the supervision and behavior of their children while at TRCC events. Children are expected to demonstrate acceptable behavior at all times, ensuring a respectful and focused environment for all visitors. Disruptive children may be asked to leave the event at the discretion of TRCC officers.

**12. Policy Changes**

TRCC reserves the right to modify this Visitor Policy at any time and will notify visitors of any significant changes.
